High-risk work groups for exposure to asbestos in Georgia include US Navy Veterans, power plant workers, shipyard workers-Kings Bay, oil refinery workers, pulp, and paper mill workers, cotton mill workers, manufacturing workers, plumbers, welders, electricians, auto mechanics, machinists, or construction workers. As a rule, the worker's exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.

According to the CDC, the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
