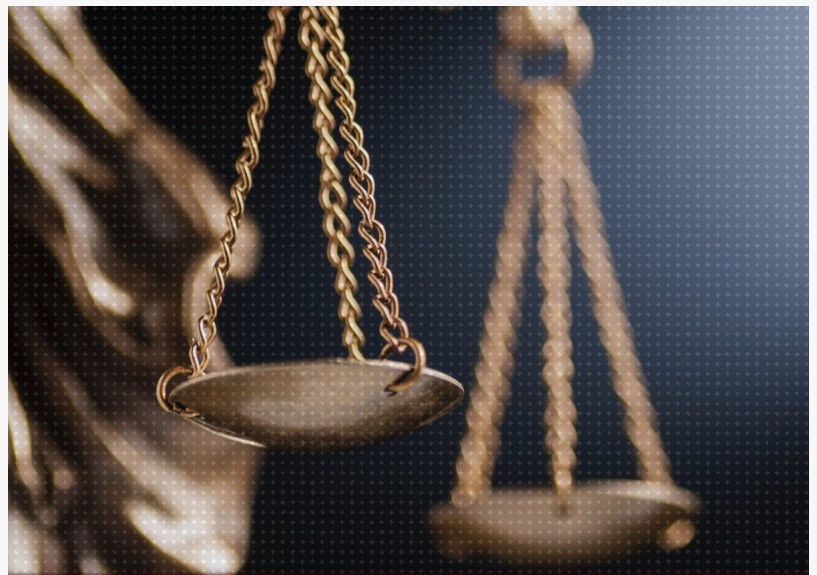

Why Hire A Personal Injury Attorney?

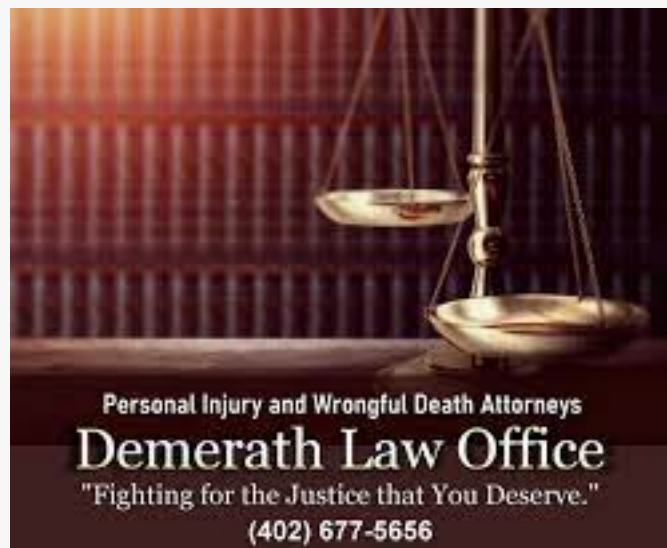
