sexual harassment laws hold employers accountable for maintaining a safe environment, free of pervasive workplace harassment."

Charles acknowledges that, most often, sexual harassment is common among those who share a work environment, such as co-workers and managerial staff. "However, it is also possible for the victim to have a different type of professional relationship with their harasser. The perpetrator can be the victim's physician, therapist, professor, or landlord."
