

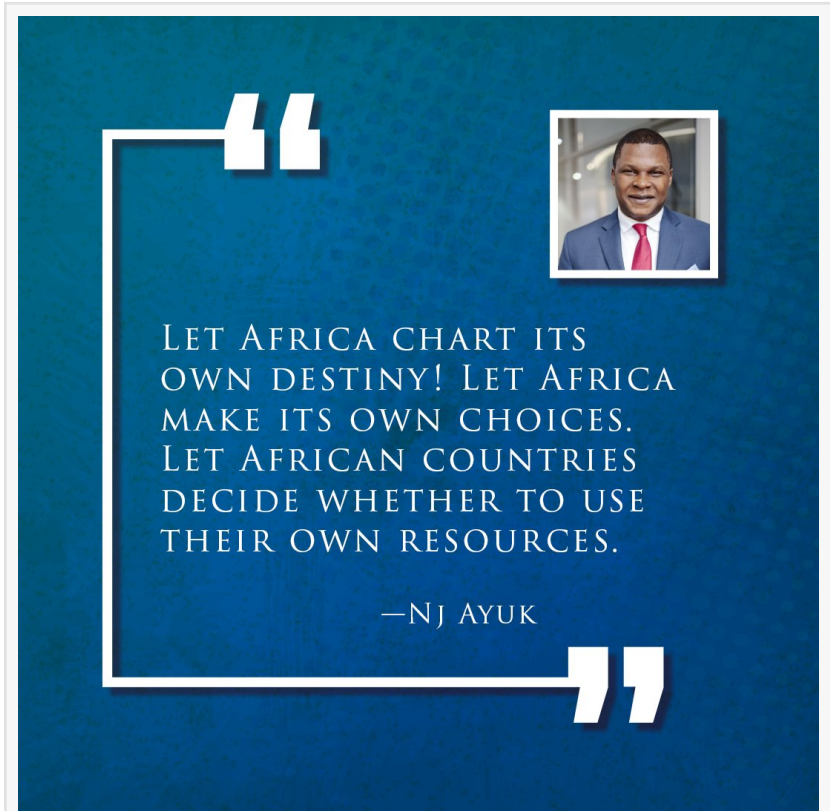
NJ Ayuk: A Trailblazer in Africa's Energy Sector

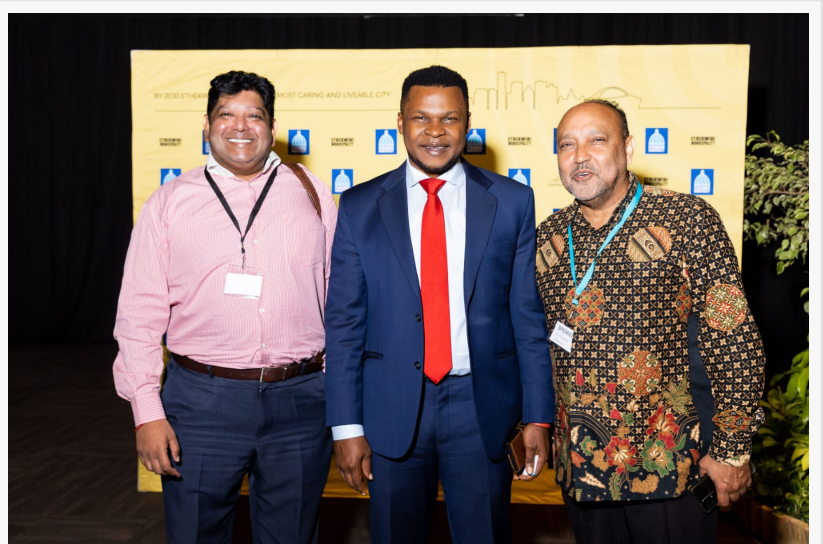
