winery in the Texas Hill Country. With over 1,900 feet of frontage on Highway 290, this Blanco County gem sits just an hour's drive from two of Texas largest cities, Austin, and San Antonio. Johnson adds a historical touch to the property and a new pole and metal barn on the site could serve any number of purposes. Every spring, the landscape is accentuated with the famous wildflowers native to the region: bluebonnets, Indian paintbrushes, red poppies, purple tansy, ox-eyed daisies, and wine-cup flowers.
