


Circularise partners with GoodFuels to digitalise the ISCC EU system for RED II compliance.

As part of this regulation, records must be maintained for the sourcing, chain of custody, and GHG emissions of the biofuel product process, and then verified by a third-party certification scheme such as ISCC EU. This process of bookkeeping is currently a manual process of companies exchanging information from PDFs and spreadsheets, which can be time-consuming and susceptible to fraud.

Adding a digital method of record management will increase information security and ease of use for any organisation that needs to report its biofuel feedstock and supply chains. By digitalising the record-keeping process, information on the chain of custody and GHG emissions of the biofuel products can be efficiently audited supporting a trustworthy and fair marine

biofuels industry.
