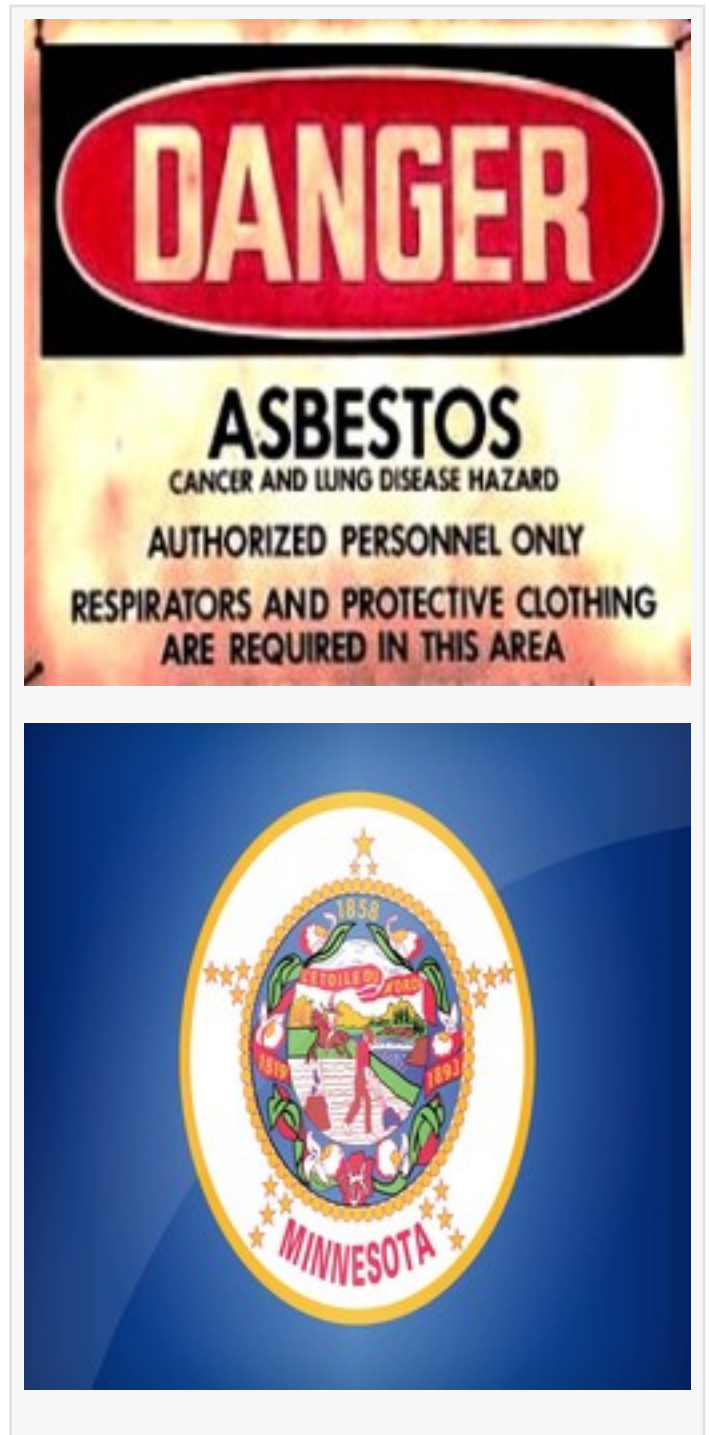
*"Do you recall the names of coworkers who might have witnessed your exposure to asbestos?
