

Lottery.com, Inc. Receives Expected Notice from Nasdaq

AUSTIN, TX, USA, November 28, 2023 /EINPresswire.com/ -- On November 21, 2023, Lottery.com, Inc. (the "Company") received written notice (the "Notice") from the Listing Qualifications Staff of The Nasdaq Stock Market LLC ("Nasdaq") indicating that, due to the Company's failure to



timely file the Form 10-Q for the period ended September 30, 2023 with the Securities and Exchange Commission (the "SEC"), as required by Nasdaq Listing Rule 5250(c)(1), the Company's securities are subject to delisting unless the Company timely requests a hearing before the Nasdaq Hearings Panel (the "Panel"). The Company timely requested a hearing and will request a further stay of any suspension action pending the conclusion of the hearing process. The Company is working to file the Form 10-Q with the SEC as soon as practicable, at which time the Company plans to seek a compliance determination from Nasdaq and cancellation of the hearing, if applicable.
