To become a Fellow of the College, individuals must be nominated by a current Fellow and then evaluated by a committee of the College's Board of Regents. Criteria for membership in the College include having been a member of the bar of one or more States of the United States (or the District of Columbia, possessions, or territories of the United States) for at least 15 years prior to the date of their election to membership as a Fellow in the College, with a career that is principally devoted to tax law and tax-related matters. Prospective Fellows must be currently engaged in (or retired or semi-retired from) full-time legal work, whether in private law practice, in a corporate legal or tax department, in a governmental legal position, in a trade association, in a law or business school or other graduate level teaching position, or a combination thereof. For all prospective Fellows, demonstration of a high standard of excellence and ethical conduct in the practice of tax law is required. This commitment can be shown in a number of ways, including through active involvement in the taxation committees or sections of national, international, regional, state, or local bar associations, as well as through significant legal writing, teaching in the field of taxation, and holding responsible senior-level office involving tax policy or administration with the federal, state, or local government, with a global intergovernmental organization, or with a multistate commission.
