

Susan Hathaway-Altman for Congress (IL-11) Wins Another In-District Straw Poll

The Republican Assembly of Lake County, in furtherance of our mission to restore good government by electing candidates who best exemplify Republican principles, has conducted a straw poll of our members in advance of the March 19 primary election. We rate each candidate as either "highly qualified", "qualified", or "unqualified". To arrive at these ratings, we host candidates at our meetings, meet them personally, and do individual research to determine their suitability for public office. A "highly qualified" rating requires a 2/3 (66 %) vote of the members, and a "qualified" rating, a simple majority (51%). Abbreviations are HQ and Q.

The RALC members present at our February 15th meeting voted as follows for the three Republican candidates vying for the Illinois 11th District of the United States Congress.

Susan Hathaway-Altman, HQ 92%, Q 8% - we rate her as highly qualified.

Dr. Kent Mercado, HQ 50%, Q 42% - we rate him as qualified.

Jerry Evans, HQ 42%, Q 50% - we rate him as qualified.

An under-vote is the reason why the numbers for two of the candidates don't add up to 100%.

Our ratings reflect what we understand to be the candidate's level of agreement with our principles: limited Constitutional government, right-to-life for all from womb to grave, the right to keep and bear arms for personal protection and to afford us the ability to resist tyranny, an unambivalent rejection of Marxist socialism, a firm commitment to Judeo-Christian morality, a belief that America must lead the world by good example, and a promise to always put America first in our relationships with foreign nations.
