It is expected that policies with renewal dates at the end of March 2025, or early April 2025, would be the first to go through this process.

Providence Mutual notified agents and regulators that the company made the decision to exit auto insurance for both

commercial and personal lines in the four states currently offered – Connecticut, Maine, New Hampshire and Rhode Island.

"We have worked tirelessly to create a seamless experience for our insureds and agents during this transition and are pleased to have a partner like Plymouth Rock who shares in our commitment to delivering exceptional service to customers and agents alike."

Providence Mutual has filed for a homeowner's discount to be available for the companion

homeowners policies impacted by this decision and expect to have it available for use in the first quarter of 2025. After this discount is available, the company will transition homeowner policies that have the multi-policy discount to the new discount as auto policies are non-renewed or moved by its agency partners.
