

Fannie Mae's latest selling guide published in November 2024 requires lenders to ensure that appraisals do not contain "subjective and prohibited language relating to discriminatory practices and appraisal bias". The guide further requires that lenders also ensure that the appraiser "was objective and unbiased in the development of the opinion of market value in the appraisal report."

To help lenders meet GSE requirements, R3 AMC's appraisal assurance service leverages Profet Review to

analyze the appraisal for bias language, unacceptable words, and all photo compliance issues. Profet Review also provides the necessary workflow support to have the appraiser fix any issues encountered. The AMC can then produce a final "pass report" from Profet Review to be attached to the appraiser submitted to the lender.
