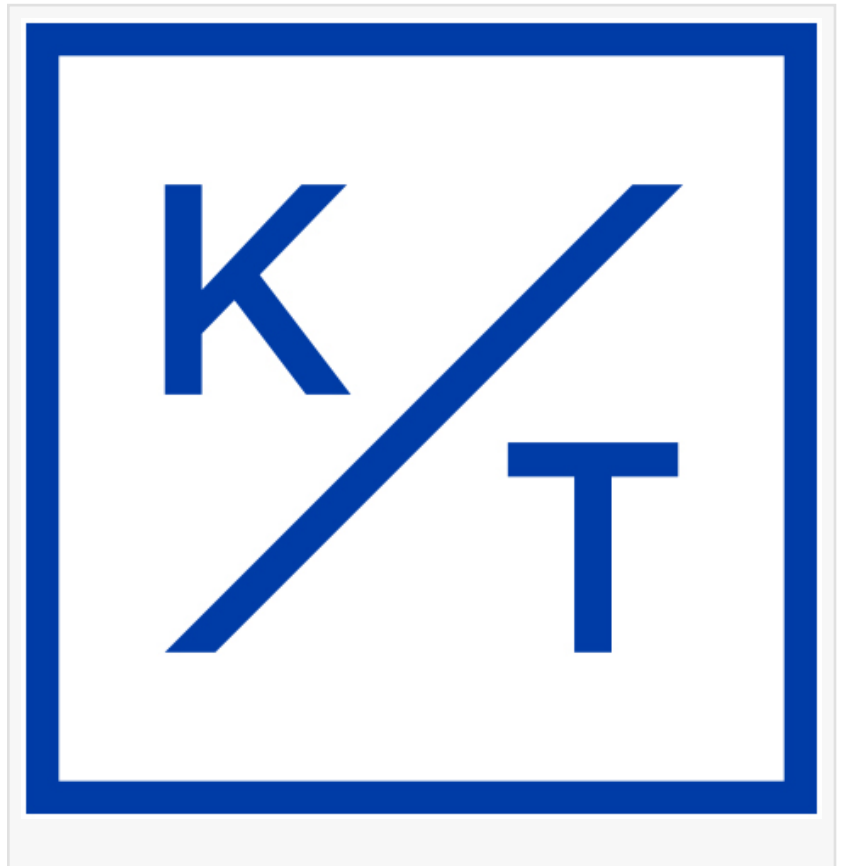

NYC REIT's stock (NYSE: NYC), which previously sold at a price of \$25 per share.
