For example, if the pool’s equipment malfunctioned and caused a swimmer to be injured or if there were no proper safety barriers to prevent a child from accessing the pool, the property owner could be held liable for failing to maintain a safe environment.

William P. Morrow, of Morrow Law Firm, notes the importance of documentation in these cases: “When an injury occurs on a property due to neglect, it’s important to gather evidence that demonstrates how the property owner’s failure to maintain a safe environment contributed to the incident. This includes photographs of the pool area, medical records, witness statements, and any other relevant information.”

### Legal Actions After a Swimming Pool Injury

In the event that a swimming pool injury occurs, the first priority is to seek medical attention for the injured person. Once immediate medical concerns are addressed, it is essential to begin gathering evidence. This can include taking photographs of the accident scene, obtaining witness statements, and keeping records of medical treatment received.

The next step is to contact a personal injury lawyer who can assess the case, investigate the circumstances surrounding the injury, and determine whether the property owner was negligent in maintaining a safe pool environment. A lawyer will help guide the injured party through the legal process, including filing a claim, negotiating with insurance companies, and, if necessary, pursuing litigation to seek compensation for the injury.
