With only three days remaining, organizations are urged to complete their filings promptly to maintain their tax-exempt status and remain in compliance with federal regulations.

The 990 series includes a range of forms depending on the organization's financial activity and structure, including Form 990-N, 990-EZ, 990, 990-PF, and 990-T. It is essential that nonprofits file the correct form applicable to their organization.
