Value-added tax was introduced in the UAE on January 1, 2018 at a standard rate of 5%. Supplies may be standard-rated, zero-rated, exempt, or out of scope. Businesses that make only zero-rated supplies may apply for an exception from VAT registration, while exempt and out-of-scope supplies are not subject to VAT. The UAE remains a leading regional hub for company formation and foreign investment, and correct registration status has become a foundational compliance requirement for both new and expanding entities.
