

Some plans also reference additional business identity services such as a domain name, website, email, and phone number, depending on the specific offer and partner channel used.

State Filing Fees: How the \$39 Service Fits Into Total LLC Costs

Market Context for the \$39 Pricing Model

Industry observers note that a flat-fee formation model of \$39 plus state filing fees may be

particularly relevant in several scenarios:

- Early-stage businesses: New or small businesses that are sensitive to upfront formation costs and prefer a clear separation between service fees and state charges.
- Privacy-focused owners: Individuals who do not wish to use a home address on public filings and instead opt for a registered agent's address where permitted.
- Higher-fee jurisdictions: States with filing fees at the upper end of the \$40-\$500 range, where the state amount accounts for most of the total formation cost.
- Owners seeking third-party filing support: Business founders who choose to rely on a third-party service familiar with state forms and processes rather than self-filing.

Northwest also lists corporation and nonprofit formation at similar \$39-plus-state-fee price points, maintaining the same pricing structure across multiple entity types.
