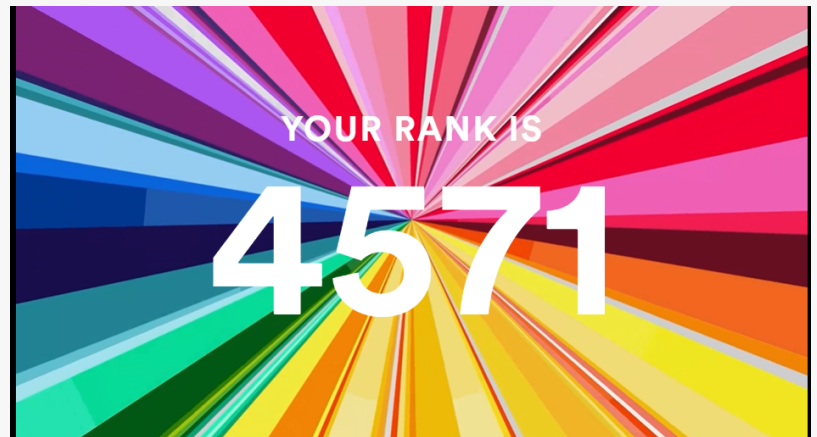

company returned in 2024 at No. 3,139 with 158% three-year revenue growth, and again in 2025 at No. 3,716 with 102% three-year revenue growth.
