Albrecht Law Successfully Appealed a Trial Court Dismissal in a Complex Personal Injury Case, Securing a Major Court of Appeals Victory for Their Client

The case stems from a collision on March 7, 2022, in which the plaintiff, represented by Albrecht Law, was rear-ended while stopped at a red traffic light. The at-fault driver claimed the crash was the result of an unforeseeable sudden medical emergency, specifically a stroke, and successfully moved the trial court to dismiss the case on summary judgment.

Albrecht Law successfully appealed a trial court's dismissal of a personal injury lawsuit, reinstating the victim's right to pursue compensation after a traffic accident and highlighting the importance of clearly proving the cause of a collision.

Refusing to accept the dismissal, the legal team at Albrecht Law appealed the decision. On October 21, 2025, the Court of Appeals agreed with Albrecht Law's arguments, ruling that genuine issues of material fact existed regarding whether the stroke actually caused the collision and whether the medical emergency was truly unforeseeable. The appellate court reversed the summary judgment, paving the way for the case to return to the trial court. "At Albrecht Law, we don't back down when a case gets tough or when a trial court makes a ruling we know is wrong," said [Matthew Albrecht](#), founder of Albrecht Law, PLLC. Regardless of the next procedural step, the Court of Appeals decision marks a massive milestone for the plaintiff.
