

ProLegal Debuts at No. 11 in Legal on the 2026 Inc. 5000 With 615% Growth

Glendale, California company ranks No. 585 nationally and No. 11 in Legal, marking its third Inc. recognition in 2026.

ProLegal, a legal industry company operating an integrated portfolio of technology and consumer funding products, today announced its debut on the [2026 Inc. 5000](#), ranking No. 11 among all legal industry companies in the United States and No. 585 nationally on 615% revenue growth over three years. The company also ranked No. 31 in the Los Angeles metropolitan area and No. 94 in California. It is ProLegal's first year on the list.

"Ranking No. 11 in the legal industry in our first year on the Inc. 5000 tells us the model is working," said Patrick Babaian, CEO and Founder of ProLegal. "I bought my first copy of Inc. as a 12 year old who had just arrived in America from England, back when it was still the Inc. 500, and I decided right then that I would own my own businesses and be on that list one day. I started my first company at 14, a web hosting and website design company in the dial up era. More than 15 companies later,

here we are."

The ranking follows a public commitment. In announcing its No. 18 Inc. Regionals Pacific placement on June 3, 2026, ProLegal stated it was targeting the Inc. 5000 later in the year.

The Inc. 5000 ranks the fastest growing private companies in America by verified percentage revenue growth from 2022 through 2025. Inclusion requires a company to be privately held, for

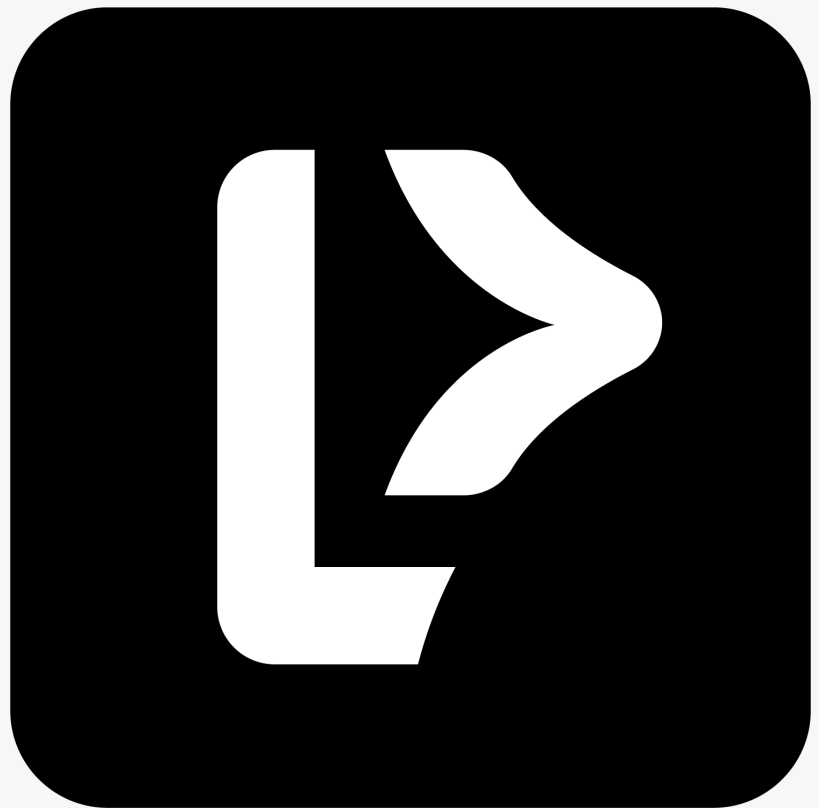
profit, independent and based in the United States, with revenue generated by March 31, 2022, a minimum of \$100,000 in 2022 revenue and a minimum of \$2 million in 2025 revenue. Applicants submit documentation to verify their revenue figures, which Inc. reviews before assigning a rank. Inc. has published the list for more than 40 years.

ProLegal was founded in 2018, placing the measurement period in the back half of the company's first decade rather than in its opening years. The Inc. 5000 debut is ProLegal's third recognition from Inc. in 2026. The company was named to Inc.'s Best Workplaces 2026 list in the Legal Industry category, a program evaluating workplace culture and employee experience rather than revenue growth. ProLegal also ranked No. 18 on the 2026 Inc. Regionals list for the Pacific region, covering California, Oregon, Washington, Hawaii and Alaska. Inc. describes the Regionals as an extension of the Inc. 5000, ranking the fastest growing private companies within a defined region.

ProLegal operates four connected solutions serving the legal industry and its clients. ProLegal Funding provides consumer legal funding, also known as pre-settlement funding. ProLegal Rides provides client transportation. ProLegal Growth is a branding, websites and marketing growth engine built exclusively for law firms. ProLegal Live operates as a full extension of the law firm, configurable by each firm from intake through substantially broader case workflow support.

"ProLegal is the last company I will ever own, and that has nothing to do with being finished," Babaian said. "It is about what this business can become, and honestly about how complex it is. We are building a full ecosystem of interconnected technology products and consumer funding products for this industry, and I do not believe there is another company out there doing what we are doing. We also have several new products launching this year that are already in the pipeline. Our expansion into Canada, the United Kingdom and Australia is well under way, and our ambitions are enormous."
