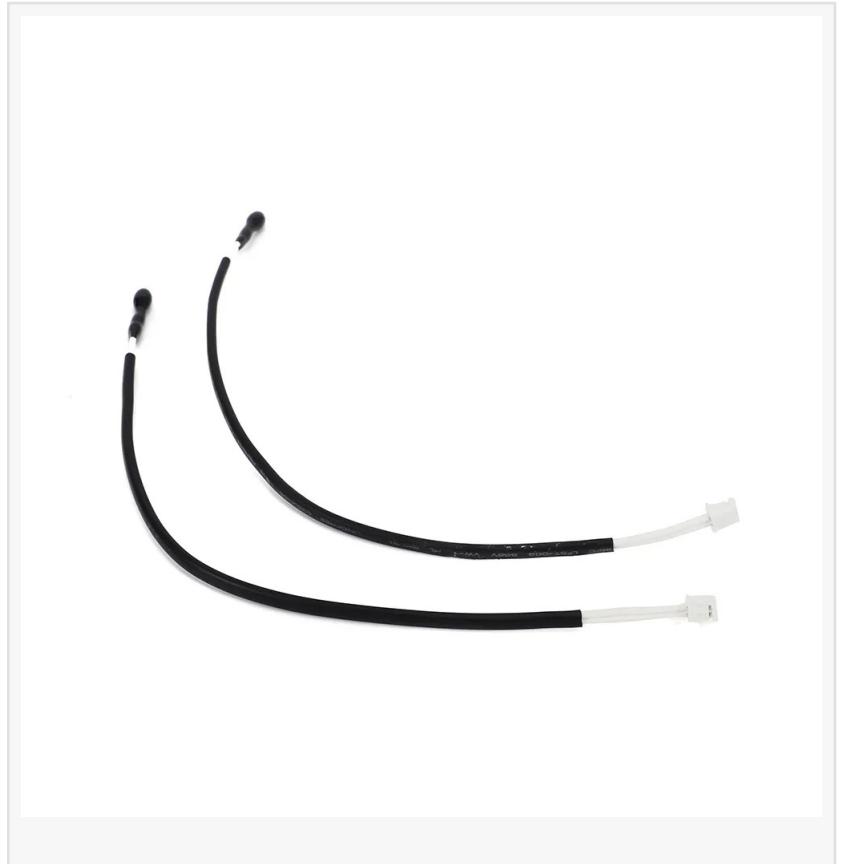


Halogen-Free Compliance Statement for NTC Temperature Sensor: Evergreen Compliance Support for Export Buyers
