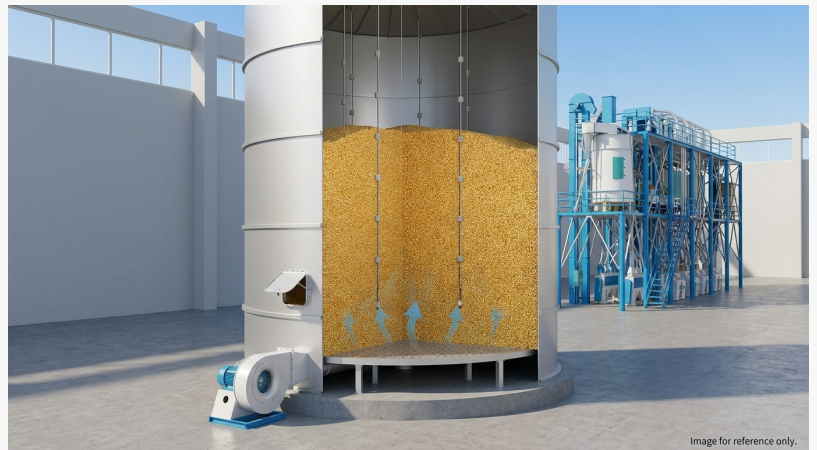

dry, temperate environments will fail to protect maize in regions characterized by high humidity and aggressive temperature swings.

Without these fundamental controls, localized hotspots and moisture migration can rapidly degrade the stored harvest, increasing the risk of mold and insect infestation, ultimately rendering the grain unsuitable for high-quality flour production.

The storability of grain is fundamentally tied to its temperature and moisture content. Aeration

systems utilize low-volume air pushed uniformly through the grain mass to establish a manageable internal temperature profile. This thermal regulation is essential for mitigating condensation and suppressing biological activity that leads to spoilage. Furthermore, operators must conduct regular checks on grain moisture and temperature throughout the storage period. Sudden temperature increases often serve as the earliest warning sign of spoilage, necessitating immediate intervention. Incorporating robust monitoring equipment and routine inspection schedules into the overall facility plan protects the raw material investment and ensures a consistent, high-quality feed for the milling operation.

Conveying, Cleaning, and Discharge Must Form One Material-Handling Plan

A successful grain storage facility requires a unified approach to material handling that eliminates bottlenecks between distinct phases of operation. The procurement plan must coordinate the entire process, including grain reception, pre-cleaning, elevating, distribution, aeration, discharging, and the final transfer to the processing line. Any restriction, mechanical failure, or capacity mismatch at these interface points will limit the overall throughput of the entire milling plant, stranding valuable capacity.
