Furthermore, product portfolios must span the entire spectrum of refractive indices—ranging from standard CR-39 (index 1.50) to mid-index 1.56, and premium high-index alternatives like 1.60 MR-8, 1.67, and 1.74 ultra-thin resin lenses. Each refractive index must be paired with precise aspheric and double-sided aspheric designs that minimize peripheral aberration, reduce lens thickness, and enhance aesthetic appeal for the end consumer.
