

Dylan Mazzei Consulting Launches With Diagnostic-First Model for Founder-Led Businesses

The new practice, founded by a four-exit entrepreneur, requires a scored business audit before any engagement and delivers roadmaps clients keep.

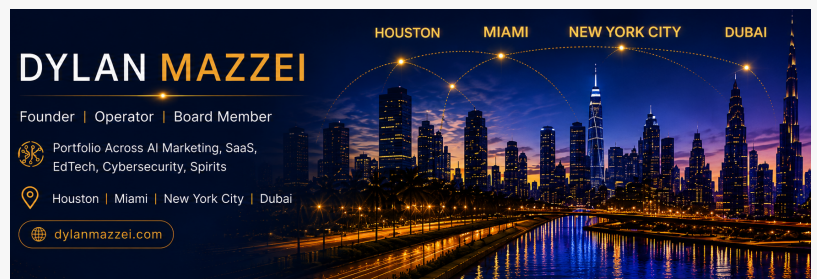
HOUSTON, TX, UNITED STATES, August 10, 2026 /EINPresswire.com/ -- [Dylan Mazzei Consulting](#), a consulting practice for founders and operators, has launched with a model that departs from conventional consulting structure: every engagement begins with a fixed-fee, scored audit rather than a proposal.

The audit, which the firm calls the Business Diagnostic, evaluates four areas of a client company: marketing and visibility, entity structure, operations, and security posture. It produces a written report with a prioritized roadmap. According to the firm, the roadmap belongs to the client whether or not any further engagement follows, a structure intended to separate the diagnosis from the sale of the cure.

The practice is founded by [Dylan Mazzei](#), an entrepreneur who has built companies across six industries and completed four exits, including an insurance agency, a marketing agency, a home health care business, and a clothing line. His current portfolio spans marketing and AI search agencies, AI software, a consumer spirits brand, education technology, and a cybersecurity assessment platform, operating from

bases in the United States and Dubai.

"Most consulting starts with a pitch and works backward to a problem," Mazzei said. "I run companies in six industries, and in my own businesses I would never spend on a fix before scoring the problem. The diagnostic-first model is how an operator would buy consulting if operators designed it."

Beyond the diagnostic, the practice offers 90-day execution sprints across six service lines, covering marketing and AI search visibility, business setup, business optimization, supply chain, cybersecurity, and education, along with ongoing advisory and fractional executive roles. The firm states that delivery for each service line runs through operating teams from companies Mazzei owns, rather than contracted consultants.

The launch follows the publication of Mazzei's debut book, "Till the End of Life," with a second book on starting a business in development.
