recognizing excellent performance,” Rollins added. “Her promotion is well deserved, and we’re confident in the leadership she brings to this position.”

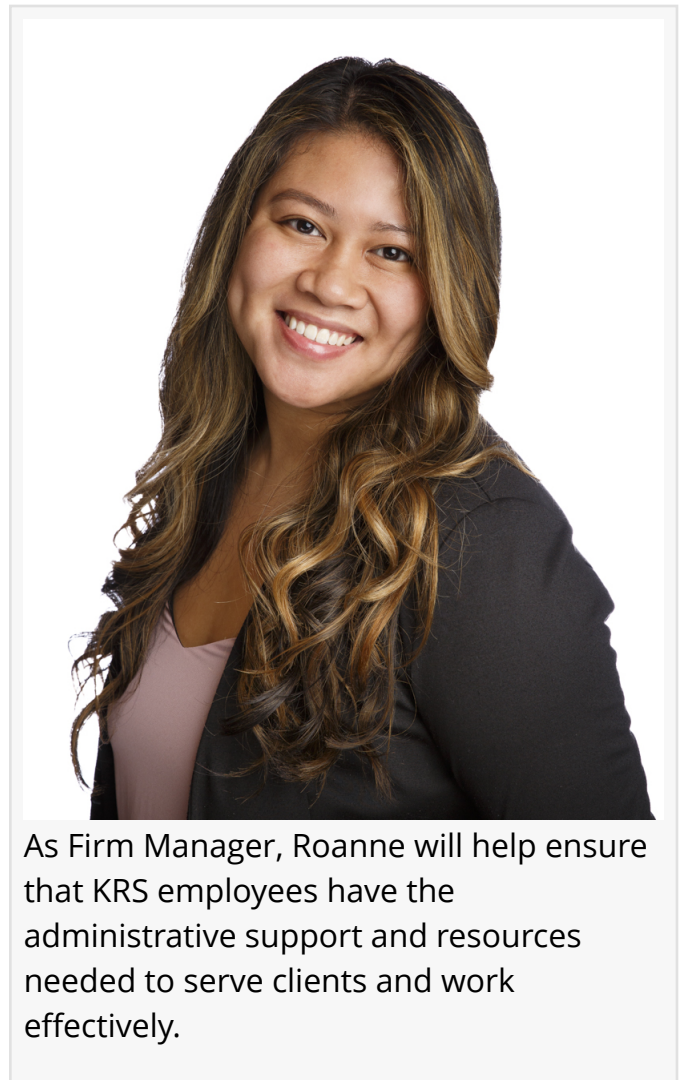
