

MOOvers Chicago Returns to the Inc. 5000 for a Second Consecutive Year

Chicago moving company records 86.45% three-year revenue growth while expanding consumer pricing transparency.

CHICAGO, IL, UNITED STATES, August 12, 2026 /EINPresswire.com/ -- MOOvers Chicago Inc., a family-owned moving and storage company based in Chicago, has been named to the 2026 Inc. 5000 for a second consecutive year. The company recorded 86.45% revenue growth during the three-year period evaluated for the 2026 list.

The Inc. 5000 recognizes independent, privately held U.S. companies based on verified percentage revenue growth. The 2026 list measures growth from 2022 through 2025. Companies must meet Inc.'s revenue and eligibility requirements, submit supporting financial information and complete an editorial review.

MOOvers Chicago has completed more than 20,000 moves since the company was founded in 2014. Its work includes local apartment and house moves across Chicago, suburban relocations, interstate moves, office moves, packing, unpacking and storage.

Supporting a larger number of moves requires more than adding trucks. Each job must be estimated, scheduled, staffed and completed according to its inventory, access and services. Dispatchers and crews need accurate information about stairs, elevators, parking, building rules, packing requirements, additional stops and delivery timing. Customers also need clear updates when closing dates or access arrangements change.

A significant number of MOOvers Chicago customers have returned when they needed another move. Some return for another apartment move, while others contact the company later for a house move, suburban relocation, storage or an interstate move. The company views that repeat business as a practical measure of whether its service remains consistent as it grows.

MOOvers Chicago has also expanded the information available to consumers before they request an estimate. Its [Chicago moving pricing guide](#) explains how factors such as crew size, trucks, inventory, access, distance, labor, packing materials, storage and additional services can affect the cost of a move.

The guide includes hourly crew and truck ranges, typical totals by home size and information about charges the company does not add, including fuel surcharges, elevator fees, long-carry fees and late-start fees. It is intended to provide a realistic starting point rather than a fixed quote. Local Illinois moves are billed under the company's filed tariff, and final requirements depend on the details of each job.
