

All Dogs Unleashed Austin Accepts Every Breed Into Board and Train as Lease and Insurance Limits Persist

Texas law bars cities from banning dog breeds, but leases and insurance policies still can. All Dogs Unleashed accepts every breed into its Austin program.

AUSTIN, TX, UNITED STATES, August 18, 2026 /EINPresswire.com/ -- Texas law prohibits cities and counties from regulating dogs by breed. Under Section 822.047 of the Texas Health and Safety Code, a municipality may impose additional requirements on dangerous dogs only if those requirements are not specific to one breed or several breeds. Austin has no breed ban, and under state law it cannot enact one.

Private restrictions are a different matter. Lease agreements, homeowner association rules, and insurance policies routinely name specific breeds or set weight caps, and none of those are bound by the state preemption. For renters in downtown Austin's residential towers, where pet addenda are standard and building policies vary from property to property, the practical result is that a dog can be perfectly legal in the city and still be a problem in the building.

Intake begins with an individual behavioral assessment rather than a breed screen.
