

Every Pet Finds a Home at Polk County Adoption Event Hosted by Brooks Law Group

Winter Haven community adopts every dog brought to local event in coordination with Polk County Animal Control

WINTER HAVEN, FL, UNITED STATES, August 19, 2026 /EINPresswire.com/ -- All four dogs available at an Aug. 1 pet adoption event hosted by Brooks Law Group in partnership with Polk County Animal Control found new families, bringing the event to an early close after every dog was adopted.

The event was scheduled to run from 10 a.m. to noon at Brooks Law Group's Winter Haven office, but prospective adopters began arriving nearly 15 minutes before the scheduled start.
