The expanded Lee County focus comes as Southwest Florida continues to experience substantial population growth. According to the U.S. Census Bureau's latest estimates, Lee County had approximately 875,607 residents as of July 1, 2025. That represents an estimated 15.1% increase from the county's April 2020 population estimate base.

As more people live, work, commute and travel throughout Fort Myers and surrounding Lee County communities, the

firm is placing greater emphasis on making personal injury information and attorney access available locally.

Ralph Sanchez Law currently represents injury clients throughout Fort Myers, Cape Coral, Lehigh Acres, Bonita Springs, Estero, Sanibel and other Lee County communities.
